MINUTES

1. Call to Order

Mayor Collum called the meeting to order at 7:00 PM.

2. Pledge of Allegiance and Invocation

The Mayor led the audience in the Pledge of Allegiance and Jerry Boss gave the Invocation.

3. Roll Call

Present and forming a quorum were Mayor Collum and Alderman Mary Boss, Pamela Romer, Robert Perez. Sondra Leigh and Larry Villarreal. Also present were City Secretary Idalia G. Vega and Police Chief John Chambers.

4. Citizen Comments

Michael Bratchi- commented on usage of Town Hall. He stated that the Activity Committee should be charged a fee for the usage of the Town Hall for such events as Coffee, Bingo, etc. Bratchi wished candidates luck on the election. Mr. Bratchi stated that he was assaulted during elections. He also commented that he does not appreciate area residents making obscene gestures to him in public.
