## ORDINANCE NO. 0013

AN ORDINANCE AUTHORIZING THE CAMERON COUNTY TAX ASSESSOR-COLLECTOR TO SERVE AS THE TAX ASSESSOR-COLLECTOR FOR THE TOWN OF INDIAN LAKE, TEXAS.

WHEREAS, the Town of Indian Lake, Texas is an incorporated Town in the State of Texas located in Cameron County, Texas; and WHEREAS, under TEX. REV. CIV. STAT. ANN. ART. 1042b, any incorporated town may by ordinance authorize the County Tax Assessor and County Tax Collector of the County in which the said Town is located in to act as Tax Assessor and Tax Collector for that Town; and WHEREAS, in Cameron County, Texas, the functions of Tax Assessor and Tax Collector are performed by one individual, the County Tax Assessor-Collector.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF INDIAN LAKE, TEXAS, THAT:

- Section 1: The County Tax Assessor-Collector of Cameron County, Texas is hereby authorized to act as Tax Assessor-Collector for the Town of Indian Lake, Texas.
- Section 2: It shall be the duty of the County Tax Assessor-Collector to perform the duties of Tax Assessor-Collector for the Town of Indian Lake, Texas, pursuant to the Ordinances of this Board. This shall include but is not limited to the collection of taxes and assessments for the Town of Indian Lake, Texas, and turning this over, as soon as possible after collected, to the proper depository of the Town of Indian Lake, Texas, or other authority authorized to receive such taxes, or assessments. All taxes or moneys collected for the Town of Indian Lake, Texas shall be collected according to the Ordinances of the said Town, pursuant to state law, less his fees hereinafter provided for.

The property situated within and subject to taxation in Section 3: said Town shall be assessed at eighty five percent (85%) of its value as it is assessed for County and State purposes.

Section 4: The Cameron County Assessor-Collector will receive for his aforementioned services an amount to be agreed upon by the Board of Aldermen of the Town of Indian Lake, Texas, and the Commissioners' Court of Cameron County, Texas. This amount, pursuant to law (TEX. REV. CIV. STAT. ANN. ART. 1042b, SEC. 5) will not exceed one percent of the taxes so collected.

Upon publication, this Ordinance shall be an effective Ordinance of the Town of Indian Lake, Texas.

WHEREAS, the Town of Indian Lake, Texas has requested Hugh

H. Riley, Tax Assessor-Collector of Cameron County, Texas to assess

and collect the taxes for the Town of Indian Lake, Texas in accordance with Article 7359, Texas Annotated Civil Statutes, Amended, and

WHEREAS, Hugh H. Riley, Tax Assessor-Collector of Cameron County,

Texas has agreed to collect said taxes in accordance with the aforesaid Article;

NOW, THEREFORE, the Town of Indian Lake, Texas, Cameron County, Texas, acting by and through its duly authorized officer, hereby contracts that Hugh H. Riley, Tax Assessor-Collector of Cameron County, Texas, to assess the taxes for said town and to perform the duties of Tax Assessor-Collector according to the Ordinances of said Town of Indian Lake, Texas, and according to law, and to collect said taxes and assessments for said Town of Indian Lake and to turn said sums so collected to the City Depository or whereever authorized by said proper authorities of the Town of Indian Lake, Texas, and Hugh H. Riley, Tax Assessor-Collector of Cameron County, Texas, agrees that he will perform the duties of Tax Assessor-Collector according to the Ordinances of said Town and according to law, and will collect said sums as due and turn said sums over to the City Depository or what authority the Town of Indian Lake has so directed.

The Town of Indian Lake and the Tax Assessor-Collector agree, and so stipulate, that Hugh H. Riley, Tax Assessor-Collector of Cameron County, Texas, shall deduct from the taxes so collected, the fees as provided by law, same being a sum equal to ONE (1%) PERCENT of the taxes so collected.

This Contract shall be in force and effect until the Town of Indian Lake or Hugh H. Riley, Tax Assessor-Collector of Cameron County, Texas has so cancelled the same by written notice deposited in the United States Mail, addressed to the other party.
