

AN ORDINANCE WHEREBY THE TOWN OF INDIAN LAKE, TEXAS SHALL ADOPT THE TITLE FOR CITIES AND TOWNS, TEX. REV. CIV. STAT. ANN. ART. 961-1132, PURSUANT TO TEX. REV. CIV. STAT. ANN. ART. 961 (1875), AS AMENDED ACTS 1881, P. 115, I.G.L. VOL. 9, P. 207; (1885), P. 57, G.L. VOL. 9, P. 667; ACTS 1915, P. 64; AND ACTS 1919, P. 110.

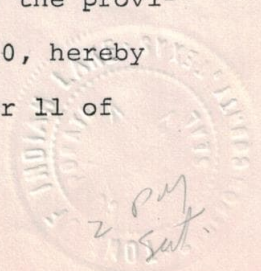
WHEREAS, Indian Lake, Texas is an incorporated town in the State of Texas containing at least six hundred inhabitants; and

WHEREAS, under TEX. REV. CIV. STAT. ANN. ART. 961, any incorporated town may accept the provisions of the title pertaining to cities, towns, and villages, in lieu of any existing charter, by a two-thirds vote of the council of such town, had at a regular meeting thereof, and entered upon the journal of their proceedings, and a copy of the same signed by the Mayor and attested by the Clerk or Secretary, under the corporate seal, filed and recorded in the office of the County Clerk in which such town is situated;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF INDIAN LAKE, TEXAS THAT:

Section 1: Pursuant to the said statute, and by a two-thirds vote of the Board, at a regular meeting thereof, entered upon the journal of their proceedings, and a copy of the same signed by the Mayor and attested by the Secretary under the corporate seal, filed and recorded in the office of the County Clerk of Cameron County, the Town of Indian Lake, Texas hereby adopts the provision of Chapters 1-10 pertaining to cities, towns, and villages.

Section 2: The Town of Indian Lake, Texas by adopting the provisions of the aforesaid title, Chapters 1-10, hereby is no longer a town operating under Chapter 11 of that same title.



The adoption of Chapters 1-10 by the Town of Indian Lake will be effective when filed and recorded with the County Clerk of Cameron County, Texas and upon publication, this Ordinance shall be an effective Ordinance of the Town of Indian Lake, Texas.

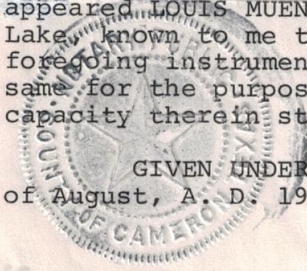
