## **AMENDMENT TO ORDINANCE 0063**

AMENDING SECTION 2 OF ORDINANCE 0063 AUTHORIZING THE POLICE CHIEF TO APPOINT AND REMOVE PAID AND RESERVE OFFICERS WITH THE PRIOR APPROVAL OF THE TOWN MAYOR

WHEREAS, The City Council of the Town of Indian Lake has determined it is necessary to amend Section 2 of Ordinance 0063 to authorize the Police Chief to appoint and remove paid and reserve officers with the prior approval of the Town Mayor;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF INDIAN LAKE, TEXAS that Section 2 of Ordinance 0063 is hereby amended to read:

Section 2: The City Council of the Town of Indian Lake, Texas, may, upon motion, appoint and hire the Chief of Police and set the compensation that all police personnel shall receive for the performance of their duties. The Police Chief shall have the authority to appoint and remove paid and reserve officers when he deems it necessary with the prior approval of the Town Mayor.

## AMENDMENT TO ORDIANCE #063 A

AN AMENDMENT TO ORDIANCE #063 CREATING A POLICE DEPARTMENT AND PROVIDING FOR THE APPOINTMENT OF POLICEMEN, THEIR DUTIES AND COMPENSATION; PROVIDING FOR THE OFFENCE OF REFUSING TO AID AN OFFICER; PROVIDING A PENALTY, SEVERABILITY AND AUTHORIZING PUBLICATION:

WHEREAS, The Town of Indian Lake has determined the necessity to amend said Ordinance #063 to provide for the appointment of Police Officers and Reserve Police Officers.

WHEREAS, The Town Council determined the necessity to amend Section 1 and Section 2 of Ordinance #063.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF INDIAN LAKE, TEXAS:

Section 1: That the Town of Indian Lake, Texas, does hereby establish a Police Department, in and for the Town of Indian Lake, which Police Department shall consist of a Chief of Police and establish a maximum position of ten (10) Police Officers and a maximum of fifteen (15) Reserve Police Officers.

Section 2: The Town Council of the Town of Indian Lake, Texas, may, upon motion, appoint and hire the Chief of Police and all subordinate policemen, set the compensation that they shall receive for the performance of their duties and the Town Council is further authorized to remove or discharge any police officer, with or without cause, who has been employed pursuant to this Ordinance. The Chief of Police shall have the authority to appoint and remove reserve officers if he determines it necessary with the approval of the Town Mayor.

This Amendment shall become effective when published and posted according to law.

## **ORDINANCE NO. 0063**

AN ORDINANCE CREATING A POLICE DEPARTMENT AND PROVIDING FOR THE APPOINTMENT OF POLICEMEN, THEIR DUTIES AND COMPENSATION; PROVIDING FOR THE OFFENSE OF REFUSING TO AID AN OFFICER; PROVIDING A PENALTY, SEVERABILITY AND AUTHORIZING PUBLICATION:

WHEREAS, The Town of Indian Lake wants to provide for the general safety and welfare of its residents and provide for proper law enforcement within the town limits; and,

WHEREAS, the Town of Indian Lake, pursuant to Article 1146 V.T.C.S. wishes to establish a police department for the enforcement of the general laws of the State of Texas and the Ordinances of the Town of Indian Lake, Texas; and,

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF INDIAN LAKE, TEXAS:

Section 1: That the Town of Indian Lake, Texas, does hereby establish a Police Department, in and for the Town of Indian Lake, which Police Department shall consist of a Chief of Police and subordinate police officers.

Section 2: The Town Council of the Town of Indian Lake, Texas, may, upon motion appoint and hire the Chief of Police and all subordinate policemen, set the compensation that they shall receive for the performance of their duties, and the Town Council is further authorized to remove or discharge any police officer, with or without cause, who has been employed pursuant to this Ordinance.

Section 3: Any policeman or peace officer, or any other person may, without a warrant, arrest an offender when there is an offense against the laws of the State of Texas or the Ordinances of the Town of Indian Lake committed in his present or within his view; or any peace officer or policeman may arrest any person when a complaint is filed accusing that person of committing an offense against the laws of the State of Texas or against the Ordinances of the Town of Indian Lake, Texas.

**Section 4:** If any person being called on by the Chief of Police or any other peace officer or policeman shall refuse or fail to aid such officer in any manner in which by law he might be lawfully called on to aid or assist in the execution of a duty incumbent upon such office he shall be fined not exceeding Two Hundred Dollars (\$200.00).

Ordinance No. 0063 continued:

**Section 5:** Any person who shall violate any of the provisions of this Ordinance, or shall fail to comply therewith or with any of the requirements thereof, shall be deemed guilty of a misdemeanor and shall be liable to a fine, and upon conviction of any such violation, shall be fined in any sum of not more than Two Hundred Dollars (\$200.00) for each offense, and each day that such violation exists shall be considered a separate offense.

Section 6: If any section, paragraph, subdivision, clause, phrase, or provision of this Ordinance shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this Ordinance as a whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

Section 7: This ordinance shall become effective when published or posted according law.
