

ORDINANCE NO. 0090

AN ORDINANCE REQUIRING THE NUMBERING OF HOUSES, RESIDENCES OR LIVING FACILITIES IN THE TOWN OF INDIAN LAKE, PROVIDING A GRACE PERIOD FOR ITS IMPLEMENTATION, PROVIDING FOR A PENALTY FOR VIOLATION THEREOF, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, the Board of Aldermen of the Town of Indian Lake find that it is in the public's interest that all houses, residences and living facilities within its corporate town limits be clearly and properly numbered to facilitate the location thereof during any emergency; and

WHEREAS, the Board of Aldermen of the Town of Indian Lake desire to pass an ordinance requiring the numbering of houses, residences and living facilities within its corporate town limits and providing for the enforcement of such requirement.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF INDIAN LAKE THAT:

- A. No person shall own or reside in a house, residence or any other living facilities without assigned street numbers attached to the exterior of the house, residence, or living facilities or some other permanent structure located in the front of the real property so that such numbers will be clearly visible from the street directly in front of the premises.
- B. The assigned street numbers shall measure a minimum of four inches and maximum of six inches in height, and shall be in Arabic numeric form.
- C. Any person who owns or resides in any house, residence or living facilities within the corporate limits of the Town of Indian Lake shall be responsible for bringing such house, residence, or living facilities into compliance with this ordinance.
- D. This ordinance shall become effective immediately upon its passage by the City Council; however, all persons shall have a grace period of sixty days from the date of the passage of this ordinance in which to bring their houses, residences or living facilities into compliance by affixing the street numbers required by this ordinance.
- E. Any person may request from the City Secretary a designated street number

for any house, residence or living facilities within the corporate limits of the Town of Indian Lake and in which such person resides or which such person owns.

- F. Any person convicted of violating the provisions of this ordinance shall be guilty of a misdemeanor, and shall be punishable by a fine not to exceed two hundred dollars (\$200.00). Each day such person violates the provisions of this ordinance shall constitute a separate violation.
