ORDINANCE No. 127

AN ORDINANCE PROVIDING FOR THE MAINTENANCE OF CERTAIN STATE HIGHWAYS AND/OR PORTIONS OF STATE HIGHWAYS IN THE TOWN OF INDIAN LAKE, COUNTY OF CAMERON, TEXAS, HEREBY REFERRED TO AS MUNICIPAL MAINTENANCE PROJECT AND AUTHORIZING THE MAYOR OF THE TOWN OF OTHER ATHORIZED TOWN OFFICIAL, TO EXECUTE AND AFFIX THE CORPORATE SEAL AND ATTEST SAME. A CERTAIN AGREEMENT BETWEEN THE TOWN AND THE STATE OF TEXAS, PROVIDING FOR THE MAINTENANCE AND USE OF THE SAID MAINTENCE PROJECT; AND DECLARING AN EMERGENCY AND PROVIDING THAT THIS ORDINANCE SHOULD BE EFFECTIVE FROM AND AFTER ITS PASSAGE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF INDIAN LAKE, TEXAS:

WHEREAS the Public convenience, safety and necessity of the Town and the people of the Town require that State Highway routes within the Town be adequately maintained; and

WHEREAS, the Town has requested that the State of Texas enter upon and contribute financially to the maintenance of said project; and

WHEREAS, the State of Texas has made it known to the Town that it will, with its own forces and equipment and at its sole cost and expense enter upon and maintain said project, conditioned upon the provisions concerning liabilities and responsibilities for maintenance, control, supervision and regulation which are set out in the form attached hereto, made a part thereof and market MUNICIPAL MAINTENACE AGREEMENT; and

WHEREAS, said project consists of those State Highways and/or portions thereof which are set put in the form attached hereto, and marked MUNICIPAL MAINTENANCE AGREEMENT.

NOW, THEREFORE, BE IT ORDAINED by the Council of Town of Indian Lake.

SECTION 1. That the public convenience, safety and necessity of the Town and the people of the Town require said project be adequately maintained.

SECTION 2. That the State of Texas be and is hereby authorized to enter upon and maintain said maintenance projects.

SECTION 3. That the Mayor, or proper Town official, of the Town, be and is hereby authorized to execute for and on behalf the Town and Agreement with the State of Texas, in accordance with and for the purpose of carrying out the terms and provisions of this order, in the form attached hereto, made a part hereto, and marked MUNICIPAL MAINTENANCE AGREEMENT. The Town Secretary in hereby directed to attest the agreement and to affix the proper seal of the Town thereto.

SECTION 4. The Mayor of the Town, having requested in writing that this ordinance take effect forthwith and there being in fact an emergency and imperative necessity that the work herein provided for be begun and carried out promptly and with expedition and that that agreement aforesaid shall be immediately made, executed, and delivered to the end that such work herein provided for may be begun and carried out promptly and with expedition. The reading of the ordinance on three separate days is hereby dispensed with and the same shall be in full force and effect from and after its passage.
