## ORDINANCE No. 117

AN ORDINANCE ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE TOWN OF INDIAN LAKE, CAMERON COUNTY, TEXAS, AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS OF SAID PROPERTY ALL THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS, ORDINANCES, RESOLUTIONS, AND REGULATIONS OF SAID CITY; AND ADOPTING A SERVICE PLAN.

WHEREAS, §43.028 of the Texas Local Government Code authorizes the annexation of territory, subject to the laws of this state; and

WHEREAS, an offer of a development agreement pursuant to §43.035 and/or 43.033 of the Texas Local Government Code has been made and rejected; and

WHEREAS, the procedures prescribed by the Texas Local Government Code and the laws of this state have been duly followed with respect to the following described territory, to wit:

Being ESPIRITU SANTO GRANT SHARE 22 2.4 acre tract of land (DEED 3.68 acres) out of a certain 17.164 acre tract out of SALDANA 156.43 acres tract M-2 (VOL 3 PG 9&9AMRCC). conveyed by "Warranty Deed with Vendor's Lien" as described in Deed number 202126041 to ROBINSON ARMEL WILLIAM & JUDY CAROL dated June 11, 2021, of the official records, Cameron County, Texas.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE TOWN OF INDIAN LAKE, TEXAS:

- 1. That the heretofore described property is hereby annexed to the Town of Indian, Cameron County, Texas, and that the boundary limits of the Town of Indian Lake be and the same are hereby extended to include the above described territory within the city limits of the Town of Indian Lake, Texas, and the same shall hereafter be included within the territorial limits of said city, and the inhabitants thereof shall hereafter be entitled to all the rights and privileges of other citizens of the Town of Indian Lake, Texas and they shall be bound by the acts, ordinances, resolutions, and regulations of said city.
- 2. A service plan for the area is hereby adopted and attached as Exhibit A.
- 3. The Town Secretary is hereby directed to file with the County Clerk of Cameron County, Texas, a certified copy of this ordinance.
